The Privacy Policy of Personal Information (the "Policy") applies to all personal information that "CDN-Video" (CDN-video LLC, TIN / CRR 7733728241/773101001), further - "CDNvideo", "We" "Us", etc. can receive information about you when using the websites, services, services, programs, products or services of CDNvideo (hereinafter referred to as the "Services", "CDNvideo Services") and in the course of CDNvideo execution of any agreements and agreements with you. 1. PERSONAL INFORMATION WE COLLECT AND PROCESS

1.1. You can perform some operations on the site and without providing personal information. But when you register for the use of the Services so that we can provide you with services, we can receive from you the following personal information:

1.1.1. Personal information that you provide about yourself is, independently at registration (account creation) or in the process of using the service:

- contact details (your name, phone and fax number, address of residence and e-mail address);
- billing information (number, expiration date and type of card, address for billing);
- demographic information (position, type of work performed, name and type of company);
- profile data, including your username and password.

The information required for the provision of the Services is marked in a special way. Other information is provided by you at your discretion.

1.1.2. Data that is automatically transferred to CDNvideo Services in the process of using them using the software installed on the user's device, including the IP address, cookie data, information about your browser (or other program that accesses the Services), hardware and software specifications, date and time of access to the Services, the addresses of the requested pages and other similar information.

1.2. CDNvideo does not control and is not responsible for the processing of information of third-party websites to which you can go to e links, through the Services CDNvideo.

1.3. CDNvideo does not verify the reliability of the personal information provided by you, and does not have the ability to assess your legal capacity. However, CDNvideo assumes that you provide reliable and sufficient personal information and maintains this information up to date.

2. PURPOSE OF PERSONAL INFORMATION PROCESSING

2.2.8. For administering your account.

3. TERMS OF PROCESSING THE PERSONAL INFORMATION OF USERS AND ITS TRANSFER TO A THIRD PARTY

3.1. With regard to personal information, its confidentiality remains, except in cases of voluntary provision by you of information about yourself for universal access to an unlimited number of persons.

3. 2. CDNvideo has the right to transfer personal information to third parties in the following cases:

3. 2 .3. The transfer is provided for by Russian or other applicable legislation within the framework of the procedure established by law;

3. 2 . 4. Such transfer takes place as part of the sale or other transfer of business (in whole or in part), and all obligations to comply with the terms of this Policy in relation to the personal information received by it are transferred to the acquirer;

3. 2 .5 . In order to ensure the possibility of protecting the rights and legitimate interests of CDNvideo or third parties in cases where the User violates the C announcing the use of CDNvideo services.

3.2.6. As a result of the processing of personal information through its depersonalization, anonymized statistical data has been obtained that is transferred to a third party for research, performance of work or the provision of services on behalf of CDNvideo.

3.3. When processing personal data CDNvideo is guided by the Federal Law of the Russian Federation "On Personal Data" of July 27, 2006 № 152-FZ.

4. CHANGES AND REMOVAL OF PERSONAL INFORMATION. OBLIGATORY STORAGE OF DATA

4.1. You may at any time modify (update, supplement) the provided personal information or a part thereof, using the function of editing personal data in the personal section of the Service.

4.2. You can also delete provided personal information, use the "Delete Account".

4.3. The rights provided for in cl. 4.1. and 4.2. This Policy may be restricted in accordance with the requirements of the law. In particular, such restrictions may include the duty of CDNvideo to keep the information changed or deleted by you for a period established by law and to transfer such information in accordance with a legally established procedure to a public authority.
