

AGREEMENT ON THE USE OF INTERNET RESOURCES CDNVIDEO.RU

(hereinafter - the "Agreement" and the "Site", respectively)

Date may 18 publication 2018

1. PREAMBLE

1.1. Publication of this Agreement, CDN-video Limited Liability Company (hereinafter - "CDNvideo") in accordance with Art. 438 of the Civil Code of the Russian Federation offers any user the network "Internet" (hereinafter - the "User") to use the functionality, tools and services of the Site.

1.2. This Agreement shall enter into force on the date of expression consent of the user with the terms in the manner specified in clause 1.4. Of the Agreement, and sets out the basic rules and principles of operation of the Site.

1.3. This Agreement may be amended CDNvideo without any prior notice, the new version of the Agreement shall enter into force from the date of its posting on the "Internet" to the above in this paragraph address, unless otherwise provided by the new version of the Agreement. In the event of any changes in the agreement, which the user does not agree, he is obliged to stop using the Site.

1.4. Getting to the use of the Site / its particular function, or go through the registration procedure as a Member of the Site, the User thereby completely without any reservations and exceptions, fully accepts the terms of this Agreement. In case of disagreement user with any of the provisions of the Agreement, the Customer has no right to use the Site.

2. USER REGISTRATION AND USE OF THE WEBSITE

2.1. Upon completion of the registration process creates a unique account users of the website, which is needed to use most features, tools and services of the Site.

2.2. For registration, the User agrees to provide accurate and complete information about yourself as prompted by the Service's registration form, and keep this information up to date. If the User provides incorrect information or have CDNvideo have reason to believe that the information you provide is incomplete or incorrect, CDNvideo has the right in its sole discretion to block or delete the User's account and refuse the User to use the Site (or their individual functions).

2.3 CDNvideo reserves the right at any time to require the user to confirm the information specified in the registration and request in connection with the supporting documents (in particular - the identity documents), the failure of which, at the discretion of CDNvideo, can be likened to giving false information and entail the consequences provided by para. 2.2. Agreement. If the data user specified in the documents submitted to it do not correspond to the data specified in the registration, and in the case where the data specified in the registration, do not allow to identify the user, CDNvideo the right to refuse User's access to the account, and use of the Site.

2.4. User information contained in the User's account, stored and processed CDNvideo under section "3" of the Agreement.

2.5. When registering user chooses a username (unique symbolic name for the account of the User) and password to access the account. At the same time CDNvideo has the right to prohibit the use of certain logins and establish requirements for the username and password (length, allowed characters, etc.).

2.6. The user is solely responsible for all actions (and their consequences) within or through the Site for User Accounts, including cases of voluntary transfer of data to the user for access to the account to third parties.

2.7. The user is solely responsible for the safety (resistance to guessing) password selected, and provides its own privacy.

2.8. CDNvideo right to block or delete the User's account and prohibit access using any account to specific functional sites is possible, and remove any content of the Site, without giving any reason, including in case of violation of conditions of the Agreement by the User.

2.9 CDNvideo the right to establish restrictions on the use of the Site for all users or for specific categories of users (depending on the place of residence of the User, the language in which the service is provided, etc.), including: the presence / absence of certain functions, the maximum term storage of information and data, special parameters are downloaded information, and so on).

2.10. The user is solely responsible for the compliance of the content posted to them the information requirements of the current legislation, including third-party liability in cases where the accommodation User of any information or content violates the rights and legitimate interests

of third parties, including moral rights of authors, other intellectual rights of third parties and / or infringes on intangible goods belonging to them.

2.11. You agree that CDNvideo is not obliged to pre-screen any kind of information that is placed and / or distributed to the user through the Site, as well as CDNvideo has the right (but not the obligation) in its sole discretion to refuse the User in the placement and / or dissemination of the data to them, and the information or delete any data and information that are available through the Site. User acknowledges and agrees that he should independently assess all risks associated with the placement, the dissemination of such information and data, including the assessment of the reliability, completeness, or usefulness of such.

2.12. The user is aware of and agree with the fact that job site technology may require copy (reproduction) of information, and the User Data CDNvideo and their processing CDNvideo for compliance with the specifications Site.

2.14. When using the site, users may not:

2.14.1. upload, send, transmit or in any other way to place and / or disseminate information that is unlawful, harmful, defamatory, offensive to the morality, shows (or a promotion), violence, cruelty and violates intellectual property rights, promoting hatred and / or discrimination against people on the racial, ethnic, sexual, religious, social discrimination, it contains insults against any persons or organizations contains elements (or a promotion) pornography Child erotica, constitute an advertisement (or a promotion) sexual services (including under the guise of other services), explains the procedure of manufacture, use or other use of drugs or their analogues, explosives or other weapons;

2.14.2. violate the rights of third parties, including minors and / or causing harm in any form;

2.14.3. impersonate another person or company representative and / or community without sufficient rights, including CDNvideo employees, as well as apply any other forms and ways of illegal representation of other persons in the "Internet" and enter user or CDNvideo in misleading as to the properties and characteristics of any persons or objects;

2.14.4. upload, send, transmit or in any other way to place and / or distribute the information in the absence of the rights to do so by law or any contractual relationship;

2.14.5. upload, send, transmit or in any other way to place and / or distribute not allowed special advertising information, spam (including search), lists of foreign e-mail addresses, the "pyramid" schemes, multilevel (network) marketing (the MLM) system of internet income and e-mail-businesses, "chain letters", but also use the site to participate in these events;

2.14.6. illegally collect or store personal data about other individuals;

2.14.7. disrupt the normal operation of the Site;

2.14.8. post links to the network "Internet" the resources, the content of which is contrary to the current legislation of Russian Federation;

2.14.9. to promote actions aimed at violation of the restrictions and prohibitions imposed by the Agreement;

2.14.10. otherwise violate the rules of law, including international law.

3. PRIVACY POLICY

Processing of Personal Data of the User is carried out in accordance with Russian legislation and policy of personal data

4. INTELLECTUAL RIGHTS AND RESPONSIBILITIES

4.1. This user has no right to reproduce, to repeat and to copy, sell or resell, and also be used for any commercial purposes, any portion of the Site (including the information available to users through the Site) or access to them, except in cases where the user has received such permission from CDNvideo, or when it is expressly provided for by the Agreement.

4.2. All facilities are available using the Site, including design elements, text, graphics, images, video, computer programs, databases, music, sound, and other objects placed within the site are subject to the exclusive rights CDNvideo, Members and other rights holders.

4.3. Use of this site is possible only within the framework of the proposed CDNvideo functional. No part of the Site, and any information posted in the framework of the Site may not be used otherwise without the prior permission of the copyright holder. By using implied, including reproduction, copying, processing, distribution on any basis, display in the frame, etc. The exception is expressly provided for by the legislation of the Russian Federation or the Agreement.

4.4. User's use of the Site, as well as any data and information content for personal non-commercial use is permitted provided that all copyright notices, related rights, trademarks, and other notices of authorship, save the name (or nickname) of the author / name of the copyright owner in an unaltered form, maintaining respective object unchanged. The exception is expressly provided for by the legislation of the Russian Federation or the Agreement.

4.5. The Site may contain links to other websites in the network "Internet" (third party sites). These third parties and their content are not checked for compliance with the CDNvideo or other requirements (accuracy, completeness, legality, etc.). CDNvideo is not responsible for any

content, materials and information on third-party sites to which the user has access in connection with the use of the Site, as well as for the availability of such sites or the information, and the consequences of their use by the User.

4.6. Link (in any form) to any site, product, service, any information of a commercial or non-commercial nature, placed under the Site is not an endorsement or recommendation of these products (services activities) by CDNvideo, except in cases when it is so indicated CDNvideo.

4.7. The user uses the site at their own risk. Tools, services or functionality of the Site are provided "as is". CDNvideo does not assume any responsibility, including compliance with the objectives of the User of the Site;

4.8. CDNvideo does not guarantee that: the site is / will meet User's requirements; It will work continuously, quickly, reliably and without errors; results that can be obtained using the Website, are accurate and reliable, and can be used for any purpose or in any capacity (e.g., to establish and / or confirm any facts); . the quality of any product, service, information, etc., obtained from use of the Site will meet User's expectations;

4.9. Any information and / or materials (including software downloads, emails, any instructions and a guide to action, etc.), access to which the user using the site, the user can use at your own risk and on their own responsible for any consequences of using said information and / or materials, including for the damage that it can cause your computer to the User or third parties for loss of data or any other damage.

4.10. CDNvideo is not responsible for any kind of loss resulting from the use of the Site by the User;

4.11. In all circumstances the responsibility CDNvideo in accordance with Article 15 of the Civil Code is limited to 10 000 (ten thousand) rubles of the Russian Federation and the responsibility of the CDNvideo in the presence of her actions guilt.

4.12. If any person register as a user on behalf of the authorized to the company, this means that the company accepts the agreement and is committed to protecting CDNvideo, its affiliates, officers, agents and employees from any claim, suit or action related to the use of the Site or violation of the User Agreement and any and all liability, including financial, with respect to claims, damages, injuries, processes, proceedings, litigation costs and attorneys' fees.

5. FINAL PROVISIONS

5.1. This Agreement shall be governed by and construed in accordance with the Russian legislation. Issues not regulated by this Agreement shall be settled in accordance with the Russian legislation. All possible disputes arising from relations governed by this Agreement shall be resolved in accordance with the applicable legislation of the Russian Federation, according to the norms of the Russian law. Everywhere in the text of this Agreement, unless expressly stated otherwise, the term "law" means the legislation of the Russian Federation.

5.2. If for one reason or another, one or more provisions of this Agreement shall be held invalid or unenforceable, this will not affect the validity or enforceability of the remaining provisions of the Agreement.

5.3. Inaction on the part CDNvideo in case of violation of the User or other users of the provisions of the Agreement does not preclude CDNvideo right to take appropriate action to protect its rights later and does not constitute a waiver CDNvideo their rights in case of subsequent similar or similar violations.

5.4. This Agreement is made in Russian and in some cases, can be provided to the user for review in another language. In case of divergence of the Russian version of the Agreement and the version of the Agreement in a language other provisions of the Russian version of this Agreement shall apply.

5.5. Nothing in the Agreement shall be understood as the establishment between the User and Site CDNvideo agency relationship, partnership relations, relations on joint activities, relationships, personal recruiting, or some other relationship, not expressly provided for by the Agreement.
